Kathy Munsey, Green Lake County Health Officer and Patti Wohlfel, Waushara County Health Officer presented a detailed overview of current statistical information compiled by the Central Wisconsin Health Partnership (CWHP) that was published in 2016.

Many of our members are still very invested in water issues so we were happy to host an informational meeting regarding the management practices of the Green Lake Watershed.

Charlie Marks, the Green Lake Sanitary District Administrator gave a presentation detailing the of efforts being made to improve water quality through sewage management and the reduction/control of residential and agricultural run-off. This essential work has been the joint effort of several local organizations with assistance from state and federal agencies. Mr. Marks also discussed the purchase of Camp Grow as a nature conservancy and the benefits this can have for the Green Lake Watershed.

In 2018, Assistant to the Secretary for Rural Development Anne Hazlett will travel to two rural communities each month to engage stakeholders, Congressional and community leaders, and the press in conversations about rural America's unique challenges and needs as part of a new initiative called **Rural Prosperity Roundtables (RPRs)**.

The driving conversation at each RPR will be centered on a regional challenge associated with a local lack of prosperity. Some topics may include lack of infrastructure or broadband, scarce advanced or continuing education opportunities in rural areas, or the death of an industry that once was a leading driver of economic opportunity in the region.

Representatives from USDA Rural Development, Chief Innovation Officer For Rural Development Gina Sheets, Rural Development State Director, members of the state Congressional delegation, state government leaders, including the Governor, Lieutenant Governor, and state economic development officials will participate in the roundtable.

RPRs will be open to the public and open press.

Matt Rothschild joined the [Wisconsin Democracy Campaign](#) in 2015 after working for The Progressive magazine for 32 years, most of those as editor and publisher. After graduating from Harvard University with a Bachelor's Degree in Social Studies in 1980, he spent the next 2 ½ years working for Ralph Nader's Multinational Monitor, a monthly magazine that covered large corporations and the World Bank.

The Progressive magazine and the Wisconsin Democracy Campaign organization share some common goals such as curbing the influence of money in politics. "In Wisconsin we've seen the corrosive influence of money in politics", Rothschild said and added that he wants the Wisconsin Democracy Campaign to continue to cast a spotlight on the corruption of the political system. He has also emphasized that a strong majority of Americans – on both sides of the aisle – are opposed to the Supreme Court's Citizen United decision that abolished limits on corporate spending in political campaigns.

His opinion pieces have run in the Chicago Tribune, the LA Times, and a host of other newspapers. He has appeared on Nightline, NPR, C-SPAN, and the O'Reilly Factor. He is a frequent guest on the Joy Cardin Show on Wisconsin Public Radio.

VOTER SERVICE

As there are multiple contested electoral positions in the area, the Ripon area League will be hosting two upcoming candidate forums.

The first forum will be for two contested city of Ripon elected positions: City Mayor and City Council 4th District. There are three candidates vying for the mayoral position: incumbent Gary Will, and challengers Craig Tebon and Jason Kauffeld. There are two candidates running for the 4th District Alderperson position: incumbent Al Schroeder and challenger Todd Elliot. The candidate forum will be held in the City Council Chambers of Ripon, on March 6th, at 7pm.

The second forum will host the candidates for two separate Fond Du Lac County Board Supervisor districts: Lowell Prill and Michael Prill for 6th district, and Gary Will and Andrew Zuelke for 2nd district. That forum will also be held in the City Council Chambers and will take place on March 14, at 7pm.

DACA GLORILY LÓPEZ

Immigration attorney **Glorily López** discussed the Deferred Action for Childhood Arrivals (DACA) program at the **2017 LWV WI Issues Briefing**.

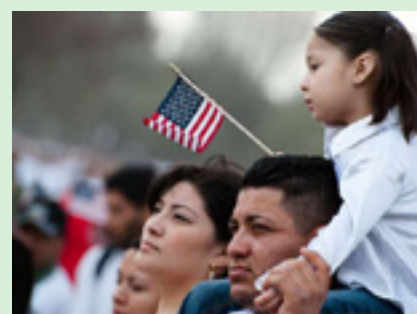
Signed by President Obama in 2014 in an Executive Action, DACA offers a limited legal pathway to obtaining a green card. It applies to previously unauthorized young people brought to the United States as children, who have grown up here, adapted to our cultural norms and the English language, and shown character and academic preparation.

Attorney General Jeff Sessions suspended DACA in September. When it lapses, an estimated 6,914 young people will lose their DACA status every week.

The Dream Act, League-supported legislation that has been introduced ten times over the past 16 years, is a bipartisan bill that would allow conditional resident status for eight years.

LWV-WI #FAIRMAPS

In January, the 37th Wisconsin county passed a Fair Maps resolution! That means MORE THAN HALF of all Wisconsin county boards—representing 64% of Wisconsin residents—that have formally asked the state to end gerrymandering and adopt a nonpartisan process for drawing the state's voting district maps.

It's high time for the Chairs of the State Senate and Assembly elections committees to hold public hearings on two bills that would have a nonpartisan legislative agency draw district maps – so legislators won't be able to "choose their voters" through gerrymandering!

Contact State Senator Devin LeMahieu and Assembly Representative Kathy Bernier and demand a public hearing for SB13 and AB44 before the current legislative session adjourns. Time is running out!

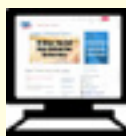
